Pursuant to Ohio Fire Code, Section 3103 (Temporary Tents and Membrane Structures) 3103.2, a permit is required for tents over 400 sq. ft. with sides or for tents over 700 sq. ft. without sides. A site plan(s), tent flame propagation performance treatment certificate(s) and a \$50.00 payment must be submitted with each permit application.

TENT PERMIT REQUIREMENTS

- 3102.1 <u>Definitions</u>: Air-inflated Structures, Air-supported Structures, Membrane Structures, Temporary Stage Canopy, Tent.
- <u>3103.2 Approval Required</u>: Permit & Approval from the Fire Code Official is Required for membrane structures having an area in excess of 400 square feet to be erected.
- EXCEPTIONS: Tents used exclusively for recreational camping purposes Tents Open on all sides & Comply with the following:
 - 2.1 Individual tents having maximum size of 700 ft.
 - 2.2 The aggregate area of multiple tents placed side by side without a fire break clearance of 12 ft, not exceeding 700 square feet.
 - 2.3 A minimum clearance of 12 feet to all structures & other tents.
- 3103.3 Place of Assembly: Shall include a circus, carnival, tent show, theater, skating rink, dance hall or other place of assembly under which persons gather.
- 3103.5 Use Period: Temporary tents, air-supported, air inflated or tensioned membrane structures shall not be erected for a period of more than 180 days within a 12-month period on a single premise.
- <u>3103.6</u> <u>Construction Documents</u>: A detailed site and floor plan for tents or membrane structures with an occupant load of 50 or more shall be provided with each application for approval.
- <u>3103.7</u> <u>Inspections</u>: The entire tent air-supported, air-inflated or tensioned membrane structure system shall be inspected at regular intervals, but not less than two times per use period except for periods of less than 30 days.
